

KICK OFF WORKSHOP TO DEVELOP FRAMEWORK FOR PROFESSIONAL STANDARDS IN SUSTAINABLE EVENT MANAGEMENT

To enable the Institute of Event Management [IEM] to function as a standard professional body it is essential to create a set of professional standards in sustainable event management to enable accreditation and validation processes and inform the membership levels.

Membership of a professional body is for individuals seeking to gain recognition for their knowledge, skills and experience. The IEM will follow the standard practices of professional bodies, in particular the CIPD [Chartered Institute of Personnel and Development] and CMI [Chartered Management Institute] both of which have excellent examples of professional standards which we are including with this programme information.

The IEM will provide professional recognition to enhance an individual's status with colleagues and employers alike, publicly demonstrating commitment to professionalism and continued professional development. Membership levels will include Apprentice/Student, Affiliate, Associate [AIEM] Full Member [MIEM], Fellow [FIEM], Companion[CIEM]. The Institute will provide a rich resource for all those who have to organise events for a wide variety of reasons.

This Workshop will bring together Practitioners [Event Managers] and Academics who are keen to support the development of the Institute of Event Management. It is hoped to have representation from all parts of the sector as set out in the Matrix [available to download at www.iem.institute].

OUTPUTS FROM WORKSHOP

This is the first of a number of engagement sessions on the transformation of the standards. It is planned to continue developing the standards through a series of online workshops. Workshop Participants are invited to consider becoming specialist sector leaders to progress the professional standards

The 'functional map' layout Key Roles A B C D have been put into separate documents and include the competencies required for both HE and Vocational Routes. Workshop Participants are invited to comment on the content and provide any appropriate revisions.

The Event Sector Matrix has been prepared as a guide to understanding scope and scale of the sector to which these standards will apply. Workshop Participants are invited to consider in particular any additional specialist competencies which should be included in the professional standards.

To enable appropriate follow up, Workshop Participants are requested to nominate a note taker for each session, provide highlights at the feedback session and send the notes to the organisers to include in follow up action plan for future sessions. Sustainable Event Management

Please note that it is planned for sustainability [environmental, social and economic impact] to be considered integral to all event management processes rather than a separate consideration.

Equity, Diversity and Inclusion

There are many ways in which these subjects are being interpreted in relation to the business of events and often little understood. It is intended to create a better understanding by highlighting them in the professional standards.

Technology

The pandemic landscape has opened up great opportunities for extending the reach of events through the use of technology. It is crucial for Event Professionals to understand the benefits of new technologies and take a fresh approach to 'live' 'virtual' and 'hybrid'.
